## MO 844/10.12.2007

*Government Emergency Ordinance ("GEO") No. 139/2007 on supplementing Law No. 346/2004 regarding the stimulation of the establishment and development of small and medium enterprises*

A new article is introduced, article 262, pursuant to which non-reimbursable financial aids awarded for the achievement of investments in production and services sectors are performed by private institutions and bodies, acting in their capacity as implementation agents of the said financial aids.

## MO 851/12.12.2007

*Law No. 350/2007 regarding the utility patterns (Romanian "modele de utilitate")*

Under law it is provided that the utility patterns protect any technical invention, provided that it is new, it exceeds the level of a simple professional skill and is susceptible of industrial application.

## MO 851/12.12.2007

*Law No. 347/2007 on the approval of GEO No. 55/2007 on the establishment of Romanian Office for Immigration upon the reorganization of the Authority for Aliens and of the National Office for Refugees, and on the amendment and supplementation of other legal acts*

GEO No. 55/2007 is approved;

It is provided that if the foreigner does not obtain any form of protection upon finalization of asylum procedure, the Romanian Office for Immigration shall issue and enforce the decision regarding his/her return.

Enters into force:

## MO 858/13.12.2007

*Government Decision No. 1511/2007 on the establishment of the December 24, 2007 as a non-working day*

It is provided that the employees of the public sector will enjoy a day free on December 24th, and will work on Saturday, the January 12, 2008 instead.

## MO 858/13.12.2007

*Order No. 2310/2007 of the President of the National Agency for Fiscal Administration (ANAF) on the registration procedure of the agreements concluded between Romanian legal entities, on one hand, and foreign legal entities or non-resident natural persons, on the other hand*

It is provided that agreements concluded between Romanian legal entities and foreign legal entities or non-resident natural persons must be registered with the competent fiscal authorities. Such agreements should be concluded in fields, such as construction works, montage, surveillance, consultancy, technical assistance and must be permanently performed in Romania. The competent fiscal authority shall be the territorial fiscal body in which area the Romanian legal entity has its fiscal domicile.
